We're combining our West Vancouver branch with our North Vancouver location

Coast Capital is committed to providing our members with the best possible service. After a thorough review, Coast Capital has made the difficult decision to amalgamate our West Vancouver branch at 1702 Marine Drive with our nearby North Vancouver location at Unit #140 - 845 Marine Drive, North Vancouver. As a result, we will officially close the West Vancouver branch effective end-of-day Friday, September 10, 2021.

The West Vancouver branch is currently operating during the COVID-19 pandemic as an appointment-only branch out of an abundance of caution to keep our employees and members safe. To help you with the transition and assist you with your banking needs before its official closure, the branch will fully reopen on Tuesday, May 11, 2021, until its permanent closure on September 10, 2021. The branch will be able to help you Tuesday to Thursday 9:30 am - 5 pm, Friday 9:30 am - 6 pm, and Saturday 9:30 am - 3 pm.

Closing a branch is always a difficult decision. While our organization remains financially healthy and stable, we have seen a significant decline in transactions at the West Vancouver location over the last several years as members' banking habits have evolved. We feel as a member-owned company that it is the right business decision to consolidate locations.

Continuing to serve the North Shore

All member accounts held at the West Vancouver location will be transferred to our North Vancouver branch located at Unit #140 - 845 Marine Drive, North Vancouver. The North Vancouver branch is open Tuesday to Thursday 9:30 am - 5 pm, Friday 9:30 am - 6 pm, and Saturday 9:30 am - 3 pm.

In addition to our North Vancouver branch, other nearby locations include our Georgia Street branch at 1075 West Georgia, Vancouver (open Monday to Friday 9:30 am - 5 pm) and our West Broadway location at 445 West Broadway, Vancouver (open Tuesday to Thursday 9:30 am - 5 pm, Friday 9:30 am - 6 pm, and Saturday 9:30 am - 3 pm). What you need to know

- Your existing memberships, cheques and preauthorized withdrawals and deposits will continue to be processed as they currently are. For administrative purposes, your membership and account transit numbers will be linked to our North Vancouver branch, but feel free to use any of our locations as your home branch.
- If you receive statements or have a line of credit, your monthly statement and line of credit payment due date will remain the same and no action is required at this time.
- If you have a safety deposit box, it will be safely and securely relocated to our Georgia Street branch at 1075 West Georgia, Vancouver. If you need to access your safety deposit box before it is relocated or want to move it to a Coast Capital branch more convenient to you, please contact the branch before Wednesday, September 8, 2021, at 604.288.3557 to book an appointment.
- **Do you use the Business Depository?** A Business Depository is available at our North Vancouver location, as well as all of our Mainland ATMs. Business Deposit debit cards are free and provide deposit-only access for businesses, as well as a receipt for each transaction. Ask us for more information.
